IP17 – SAFER OWNERS and LESS LETHAL AMMUNITION

Safer Owners - Permit-to-Purchase required for all firearm purchases

- · Complete safety training classroom and live-fire
- · Pass background check No sale of gun before the check is completed
- · Improved database assists tracking guns that are lost, stolen, used to commit crimes

Less Lethal Ammunition – Bans future sale of Large Capacity Magazines

- · Prohibits manufacture, sale, transfer and possession of magazines over 10 rounds.
- · Previously owned magazines may be retained with limited use.
- Exception for duty-only use by military and law enforcement

HOW WILL THESE CHANGES MAKE OREGON SAFER?

Requiring a Permit-to-Purchase a firearm increases responsible gun ownership

- · Permits reduce homicides, suicides, gun trafficking and shootings of police
- · Nine other states already have similar laws
- · CT licensing law led to gun homicide $\sqrt{28}\%$ and gun suicide $\sqrt{33}\%$
- MO repealed licensing law, gun homicide ↑47% and gun suicide ↑ 24%¹

Requiring Passing a Background Check is supported by a vast majority.

- · Sale of a gun without a completed background check in 2015 armed a shooter who killed 9 worshipers during a prayer meeting at Mother Emanuel AME church in SC
- · In 2018, almost 4,000 guns were sold to prohibited buyers because the background check took longer than 3 days²
- · Current Oregon law allows 3-day release of a firearm without a completed check

Less Lethal ammunition will save lives

- · Large-capacity magazines result in a higher death toll in mass shootings up to 62%3
- The shooter at Sandy Hook Elementary had ten 30-round magazines. In 4 minutes, he shot 154 bullets, killing 20 children and 6 adults. Eleven children escaped while he reloaded.
- Reloading also allows intervention by law enforcement and others⁴
- · During the Gabby Giffords shooting, Patricia Maisch disarmed the shooter while reloading⁵
- · Nine states and the District of Columbia have enacted bans on large-capacity magazines⁶
